Mayor's Report, February 16th 2017

Latchford Control Dam Project

The \$184,830 transfer from PSPC to the Town is set to occur tomorrow through our solicitor's office. It is about two months overdue but the amount hasn't changed and that is the critical thing.

ONTC Land Acquisition

I contacted Rebecca McGlynn of the ONTC to attempt to make an appointment to meet with Corina Moore, ONTC President. After exchanging emails and receiving one from Corina, we are tentatively scheduled for a call between 4 and 5 today.

Natural Gas Services

The province must have heard us talking about it at our last meeting because on January 31 they announced a new program to assist with the expansion in un-serviced communities. We followed up on this with Perry, Jaime and I having a conference call with Chris Minor and Glen Huard of Union Gas in North Bay on February 07. I have attached a summary of that call to my report but am waiting some further clarity on the surcharge that will be imposed on new customers. I apologize for the lack of certainty in some areas of the summary.

Improved Internet Service

The proposal from Parolink has been indicated to cost the Town either \$62,500 or \$125,000, depending on the length of time for completion and this is on top of the "connect to innovate" grant. Coleman has requested that the proposal be tabled for their services and Michelle has to know whether we wish to proceed. If not she wants to notify Quantum Express so they do not expend a lot of time and effort on this.

Going a different route, Dan Cleroux shared a contact with a "Cyrus Ghassabeh" of Forbes Brothers that does the tower installations for Xplornet and I spoke to him about the concerns we have about installing at the S Corners, 9 km south of Town. While assuring me that he only does what the customer wants he did confirm that the intent was to install the transmitter on the Roger Tower at that location but he provided me with contact information for Xplornet.

Jaime and I spoke with a Jennifer McWilliams of that firm on January 27 at which time we expressed our concerns about the lack of a proper signal even for local cell phone users and did not expect anything better from broadband internet service from that location. She listened and responded with the following email.

"Hello George and Jamie, Thank you so much for your time this morning and the insight you provided on the area. Our conversation was timely; our network team was working on the design. I have taken your feedback to our RF Design team; they are re-looking at the overall design now. I will keep you both posted on the progress and we may need your assistance with helping find a tower or a location for tower.

I have not heard anything more from Xplornet but I think that at some point soon, we should be approaching Anthony Rota with our concerns about signal strength from that location using federal government support to provide it. Discussions with NeoNet seem pointless.

February 16th, 2017 Report from Councilor Jo-Anne Cartner

- Medical Clinic Dr. Roedde has now returned from vacation and appears to be tanned and well rested. During her absence, Dr. Ted Mitchell and Dr. Frickers covered the patient load at the clinic. We will probably have a meeting in March before the clinic's year end.
- Fred Keenan Centre Delores has had the merchandise in the hallway and washrooms removed. She's contacted the owner of the bins that are in the vestibule and is still waiting for her to come pick them up.
- I have had a few telephone conversations with Betty Stone, Chair of Timiskaming Home Support, about Stand Up which is a free exercise and information program for older adults. Educational information sessions on how to create a safe living environment and ways to adapt your home to prevent falls as well as information about medication, proper footwear and proper nutrition are just part of the program geared to help increase seniors' independence. This program is part of the Provincial Patients First Initiative which integrates all levels of health care delivery to the patient. Betty will be providing me with more detailed information about this initiative and how areas of the program may be of benefit to the older adults here in Latchford in the future.
- George, Jaime and I attended the CCL meeting in Cobalt on Tuesday morning. Michelle updated us on the following:

Regional Mapping Project – The RFP is going out now for qualified applicants to develop a double-sided 24 by 24-inch map outlining ATV and snowmobile routes in Cobalt, Coleman, and Latchford on one side and maps of the individual municipalities with points of interest, services etc. on the other side. The committee hopes to have the maps developed and printed for June.

The Frog's Breath funding application for the Museum washrooms is ready to go once Michelle receives some specifics needed for the grant. She is also going to submit an application for the Access 4 All – Barrier Busting Grant which could be used to make the Museum more accessible.

Connect to Innovate Grant – for improved internet service is ongoing and the grant now has an April deadline instead of March 13th. Michelle is still waiting for information from Parolink and Anne-Marie Leroy.

 Michelle met with Mike Beaupre last week and will be submitting two grant applications to help with the Fire Department expansion, the Agri Spirit Grant and TransCanada Pipeline Community Grant once Mike sends her the link.
