Report from Councilor Jo-Anne Cartner

Medical Centre

- Lise and I met with Dr. Roedde on May 29th. She presented us with a detailed report of the Latchford Health Centre from Ministry stats which showed comparisons between our medical center, the LHIN and the province.
- Comparisons were shown in Preventive Screening, Diabetes Management testing
 measures, Emergency Department visits were areas where the Medical Clinic did better
 than the LHIN and the province. However, a higher percentage of the clinic's patients
 have been issued prescriptions for narcotics/opiates than either the LHIN or the
 province.
- Dr.Boisonneau from Timmins will now do 3 days a month in place of Dr. Fricker who is
 focusing on his North Bay practice. Dr. Mitchell continues to do locums and some of Dr.
 Roedde's graduated students have also offered to fill in. Her students have once again
 given the Northern Ontario School of Medicine a very good evaluation of Dr. Roedde as
 a teacher.
- Footcare for diabetics and seniors has been added to the other services the Medical Centre provides.

The CCL Committee continues to meet every two weeks to work out all the details of the Green Mining Event.

Mayor's Report, June 21, 2018

Xplornet Internet Service

There appears to have been little progress made in providing this service from the Latchford tower to most of Murphy Mill Road. While they did manage to get a signal at Bob MacArthur's it involved mounting and antennae on his boat house and actually having to remove a couple of trees. This despite the assurances that the email included in my last month's report identified as to how they were going to develop a solution. This lack of progress to resolving the signal issue for some areas of Latchford has resulted in considerable anger being expressed and frustration felt by at least one resident of Murphy Mill Road. This individual blames me and Council for this lack of progress in resolving the problem.

In following up, once more, I am told that the funding for this upgrade in wireless service went directly from the federal government level to Xplornet and did not flow through NeoNet? I will continue my efforts, with Jaime's help, to identify the funding source and program to provide the new service and find out whether there is a service performance level that has to be met.
