THE CORPORATION OF THE TOWN OF LATCHFORD BY-LAW NO. 2020-015

BEING A BY-LAW TO APPOINT A MUNICIPAL LAW ENFORCEMENT OFFICER FOR THE PURPOSE OF ENFORCING MUNICIPAL BY-LAWS.

WHEREAS pursuant to Section 15 (1) of the Police Services Act, R.S.O. 1990, as amended, Council of a municipality may appoint persons to enforce the by-laws of the municipality;

AND WHEREAS Section 15 (2) of the Police Services Act, R.S.O. 1990, as amended, defines municipal law enforcement officers as peace officers for the purpose of enforcing municipal by-laws;

AND WHEREAS the Provincial Offences Act R.S.O 1990, c. P 33 provides for the designation by a Minister of the Crown of any person or class of persons as a Provincial Offences Officer for the purposes of all or any class of offence;

AND WHEREAS by Orders dated July 30, 1984 and August 21, 1987, the Solicitor General has designated all employees whose duties include the enforcement of municipal by-laws and persons appointed as Municipal Law Enforcement Officers under the Police Services Act as Provincial Offences Officers;

AND WHEREAS the Council of the Corporation of the Town of Latchford deems it necessary and expedient to appoint Pete Gilboe as the Municipal Law Enforcement Officer for the purpose of enforcing the by-laws of the Town of Latchford;

NOW THEREFORE the Council of the Corporation of the Town of Latchford enacts the following:

1. That Mr. Peter Gilboe is hereby appointed at the pleasure of Council as the Municipal Law Enforcement Officer for the purposes of enforcing all by-laws of the Town of Latchford. As per schedule "A" be adopted.

Schedule A to BY-LAW NUMBER 2020/015

TO APPOINT A BY-LAW OFFICER FOR THE TOWN OF LATCHFORD.

- Services will be billed at a rate of \$25 per hour. These services will include but will not be limited
 to: conducting routine patrols to meet with the public, provide information, and identify areas
 of concern, responding to complaints, conducting field investigations, report writing, court
 attendance, administrative duties, and attendance at council, staff, and public meetings
- Reimbursement for mileage at a rate of 45 cents per kilometer for any mileage incurred while
 performing the duties above. Mileage incurred by me for travel to and from the Town of
 Latchford from my residence will be my responsibility.
- 3. The By-Law Officer (Peter Gilboe) will be covered under the Town Of Latchford insurance policy in regard to liability
