5. Power Dam Special Payment Program

WHEREAS in December 2000, the Province of Ontario passed the Continued Protection for Property

axpayers Act, (Bill 140);

T

WHEREAS the Continued Protection for Property Taxpayers Act, among other matters, exempted certain hydro-electric stations and poles & wires from municipal taxation as of January 1, 2001;

WHEREAS the Continued Protection for Property Taxpayers Act removed the right and authority of affected municipalities across the Province to levy property tax notices to hydro-electric stations, poles & wires, representing significant taxable property assessment;

WHEREAS the Province of Ontario replaced the above noted rights and authority to tax hydro-electric stations, poles & wires with a compensatory payment, known as the Power Dam Special Payment Program, equivalent to the taxes levied on the subject structures in 2000;

WHEREAS the amount of payments under the Power Dam Special Payment Program were adjusted for the Consumer Price Index in some but not all years, an adjustment which did not keep pace with either changes in municipal taxation rates or costs;

WHEREAS the above noted changes resulted in an unfair shift in taxation to the remaining property assessment base, more specifically to residents and businesses alike:

WHEREAS upon exempting from municipal property taxation, hydro-electric stations, poles & wires that had been subject such taxation, the Province of Ontario amended the Electricity Act, 1998 requiring the owners of the subject structures to then pay to the Province of Ontario a Gross Revenue Charge (GRC) of three components:

- A property tax component payable to the Minister of Finance
- A property tax component payable to the Ontario Electricity Financial Corporation
- · A water rental component payable to the Minister of Finance

WHEREAS in July 2014, the Province of Ontario introduced Bill 14, Building Opportunity and Securing Our Future Act (Budget Measures) which phases down or decreases the Power Dam Special Payment Program for hydro-electric stations, poles & wires by 23,53% by 2017, starting in 2015

WHEREAS the reduction in the Power Dam Special Payment Program will result in a reduction of annual revenues for affected municipalities by 2017;

WHEREAS District Social Services Administration Boards (DSSAB's) that use the proceeds of the Power Dam Special Payment Program as part of their funding formula will also be directly affected, thereby affecting municipalities who do not participate in the Power Dam Special Payment Program;

WHEREAS many municipalities are already struggling as a result of accelerated cuts to the Ontario Municipal Partnership Fund (OMPF), the unknown aspects of a new OPP Billing Model, the elimination of the Connecting Link Program and other cuts;

WHEREAS as a result of reductions in the Power Dam Special Payment Program, affected municipalities may not be able to meet their fiduciary obligations;

WHEREAS the reduction in the Power Dam Special Payment Program is punitive in nature;

WHEREAS the Power Dam Special Payment Program is very small when compared to the multi-billion dollar annual budget of the Province of Ontario yet the impact of the decreased funding is devastating for affected municipalities;

WHEREAS affected municipalities will have to increase property tax rates to the remaining property assessment base (assessment in some cases which is decreasing) to compensate for the loss of revenue or be forced to significantly compromise municipal services;

**THEREFORE BE IT RESOLVED** that the <u>Town of Latchford</u> request that the Government of the Province of Ontario reverse the decision to decrease funding to the Power Dam Special Payment Program;

**FURTHER** that the Province of Ontario also be requested to annually increase the amount of funding by the amount of any change in the Consumer Price Index (CPI) to compensate for the increase in municipal costs;

**FURTHER** that a copy of the Resolution be sent to the Premier of the Province of Ontario, the Minister of Finance, the Minister of Municipal Affairs, the Minister of Northern Development and Mines, the Minister of Natural Resources, local MPP, the local DSSAB FONOM, NOMA and AMO.

## Mayor's Report, August 21, 2014

### **Latchford Control Dam Project**

The partnership of Timiskaming & Temagami F.N.'s, Coleman Township and Latchford, have been unable to arrive at a satisfactory MOU with WPG to this date. The Communities of the Montreal River (or CMR) delegated Jeff Barton to attempt to negotiate with Colin Digout of WPG but it was the consensus of the CMR that WPG was being unreasonable and unrealistic in their demands. We will be holding a joint meeting of the CMR on Tuesday followed by a conference call with Bill Touzel of Blumetric to examine ways to move forward with the acquisition of the FIT contract on the dam.

While it was stated that tenders for the reconstruction of the dam would be called in July, I have not received any notice to confirm that they have been called but will continue to monitor. Efforts are ongoing to arrange a meeting with PWGSC regarding transfer of their surplus land in Latchford to the Town and to arrange an operations agreement on the new dam.

#### **Fuel Wood Situation**

They are once more issuing fuel wood permits in the area. The locations that have been identified that are close to Latchford include one at the North end of the Roosevelt Road near Little Blueberry Lake which has actually been harvested for a number of years. There is one at the south end near McNabb Lake which is anything but convenient for local use. The third one is west of Moose Lake.

There is an identified, suitable location just off the Roosevelt Road close to the Hearst Lake Creek which will be proposed to the MNR for permitting and John Vanthof's assistance will be requested to obtain it.

#### **OPG Emergency Response Exercise**

Jaime and I participated in a follow up conference call hosted by Tali Serota and Bruno D'Argangelo of OPG. Also participating was representatives from Elk Lake, Coleman Township and the City of Temiskaming Shores. It provided the outline for a mock emergency exercise that is planned for September. Latchford will be playing a prominent role in the exercise. Due to the "mock emergency" nature of the exercise, Jaime and I are limited in what information we can share at this point.

#### **Power Dam Compensatory Payments**

Jaime and I were invited to participate in a conference call hosted by Wawa with respect to the planned reduction announced in the last provincial budget of these payments that are received as a Payment in Lieu by Latchford. It is the province's announced intention to cut these payments by 23% by 2017. The Mayor of Wawa was requested to have another six or seven



Mayors in addition to herself participate in a conference with Assistant Deputy Minister of Finance, Allan Doheney, and other staff from MoF, OMAFRA and MMAH. In addition to Wawa and Latchford, participants were from Espanola, Merrickville, Madawaska and Iroquois Falls.

We jointly stressed to the provincial representatives the impact that these proposed reductions would have on any of the recipient municipalities and the total amount, while trivial to the provincial budget, were very significant to the municipalities presently in receipt of them. The Latchford point that was stressed was that prior to any proposed reductions, they should be first be made equitable and provided Hound Chute and Ragged Chute differences as an example. They concluded the call by stating that they would be communicating directly with the impacted municipalities.

This could be construed as a divide and conquer approach so it was recommended municipal staff share the exchanges they have with MOF after these calls.

# Report from Councillor Dave Willcock August 21, 2014

Re: Natural Gas Extension to Service Latchford:

Nothing new to report

Water Metering:

Previously I had reported that water metering was becoming less expensive than it had been in the past. I have since seen water meters, new, and with stainless steel bodies, and pulse outputs for external reader heads, for as little as \$75.00 per unit. These are available in the U.S., and Patrick is going to provide me with the provincial standard requirement so that I may inquire of the manufacturer whether they meet this spec. Purchasing meters without being certain of their legality would not be wise.

LAS Energy Program:

Towers South of town.

Triple Towers South of town, East side of Highway 11:

At the last meeting, there was discussion about a new building located near the East tower, that was erected without a permit. It appears on Google Maps, but when I drove out to the location, I could find no sign of it, even though I was exactly on the location.

I also visited the middle tower and the West tower, both of which have substantial buildings and fenced compounds. I think it would be wise to confirm that we are receiving taxation from these sites.

Details of the West tower:

This tower has a building on location that measures 21' N-S, and 37' E-W. The square footage of the footprint is about 777. It is approximately 13' tall. It has concrete walls and a concrete foundation. It appears to share its electrical service with the nearby center tower. The tower itself is within a fenced compound that measures 50' E-W, and 65' N-S. A sign identifies the property as #9021

Details of the Middle tower:

This tower has a building on location that measures 56' N-S, and 22' E-W. The square footage of the footprint is about 1230. It is approximately 10.3' tall. It has steel walls and a concrete foundation. It has an electrical service (meter# J3018251, in case this is needed to find out who owns it). The tower itself is within a fenced compound that measures 45' E-W, and 37' N-S. A sign identifies the property as #9025

East Tower:

The East tower has a building that is within its fenced compound, and cannot be measured without access through the gate. It is a small building, around 100 square feet.

#### Notes:

- The Town Office had a good reduction of power consumption this month compared to last year.
- The Fire Hall had a dramatic increase in consumption compared to last year. This is the second time I have reported it. We need to determine the reason.
- The power consumption at the community centre increased substantially. Perhaps we can have the thermostat programming changed slightly to see if this can be brought back down? We could also check to see if Monique has any continuous use lights that could be changed to LED's or another low energy alternative. I would suggest that the town pay for this.
