## Latchford 2013 Budget

It should be of no surprise to any rate payer of the town Latchford that we have been under financial distress in recent years with regards to paying off some big loans and unpaid school taxes.

However this council has and will continue to insure that our tax dollars are spent appropriately, we continue to pay off our outstanding school board taxes and our outstanding debt every year, in 2013 we are paying \$150,90 to just that.

What you should know; this year in 2013 there will be a 5.7% increase to residential taxes, 3% increase to pipeline, a 15% increase in water and sewage and a -4.0% decrease in commercial.

Last year in 2012 residential increased 7.2%, water and sewage increased 15% , pipeline increased 3% and commercial increased 3.6%

Water and sewage have seen the highest increase over this term, an annual 15% per year. When this council took over we recovering only 47% of the actual cost, we are now recovering around 80% of our actual cost.

We have also gone after our unpaid taxes and water bills which had added up to over \$80,000 owed to the town. We have also been liquidating property that could be sold to generate revenue to pay off our long term debt and school board taxes, this year alone we have raised over \$130,000 in property sales.

The council of the town of Latchford has been working hard to secure our towns financial state. It is not fun or rewarding to be the council that has to cut back like we have this term, but this is a job that must be done in, and we the elected to do so.
