Mayor's Report, June 17, 2019

PSPC Communication

At the direction of Judith Bennett, I have been in contact with Helene Belanger of PSPC with regard to the plaque unveiling at the old log lifter by the dam. In discussion with Emma, we have come up with a date, June 30 and a time, 1:00 pm for the unveiling and dedication. These plaques will pay tribute to previous dam operators, the old dam and an overview of Latchford history.

Further with PSPC, Jaime and I will be meeting in Ottawa on June 26th with Jo'Anne Bates to review and discuss the land transfer that is presently ongoing with PSPC. The intention is to have this transaction move forward as expeditiously as possible. Judith Bennett agreed this was a good approach to use to ensure that the process is expedited correctly. Also attending the meeting will be Helene Belanger who is Roger Clark's primary contact with respect to ground maintenance at the dam and other aspects of their presence in Latchford.

Union Gas

I confess to not having given this file the diligence it needs this past month due to too many other issues I have had to respond to. I leave this as a reminder to myself to keep working on it. **Derailment Building Materials**

I am confident that everyone is well aware of the progress that the LVFD and various other volunteers are making with respect to recovering building materials from the site. The material was not released to the Town until May 29 but the LVFD were on site that weekend. Considerable progress is being made with respect to removing the product. I have been authorized by Chief Mike to reach out to a purchaser for the broken dimensional lumber from the site and that opportunity looks very positive.

ONTC Communication

After presenting a very brief synopsis of a conceptual plan on the restoration of rail passenger service on the ONTC, I gained some attention from that body in relatively short order. I first received a call from Northern Ontario Business who was doing a story on the plan who quoted me in the story. I then was contacted by Tom Laughren, former Mayor of Timmins, who is now the Chair of the Ontario Northland Transportation Commission who assured me that the ONTC are very supportive of rail passenger restoration despite what was stated in the synopsis. Following that I received an email from Rebecca McGlynn, an assistant to Corina Moore, ONTC President. I responded to her email and that was followed with a call that included both Rebecca and Corina which focused on assuring me that the y are very supportive and working on the restoration of rail passenger service on the ONTC. Corina committed to having a conference call with all the Mayors before the end of June.

First Resource Management Group presentation

I was requested to attend and present an overview of municipal impacts from forestry activities to a vastly expanded number of professional foresters in Temagami on May 23. FRMG are now managing the Temagami District and it was their hope that local knowledge being shared with a number of Foresters who had never been employed in this area would be beneficial to them going forward.

Team Highway 11 Meeting

We held the first meeting of the Team Highway 11 group in Temagami on June 04. This is a relatively new initiative of the MTO and the OPP that focuses on safety issues relative to specific sections of two lane highways. The team is comprised of 6 representatives of the MTO, two senior OPP, the Mayors of Latchford, Temagami and Temiskaming Shores and a representative from GEMS. The focus of this team will be the highway from North Bay to Temiskaming Shores identifying safety concerns and working to remediate them. This effort will be done through bi- annual meetings and I have invited them to hold the October one here in Latchford.
