I am in the process of looking at some training as well as a new class 1 ladder for the town.


The windows at the museum have been painted.

#### BY-LAW ENFORCEMENT REPORT TO COUNCIL

## September 7, 2023

This report covers the period from April 15 – September 7, 2023

- A) New Complaints
- 1. Loose dog at beach park area late August
